

By Deed dated the 26th June 32nd Charles II., 1680, Elizabeth Smith, the widow of Robert Smith, released her right to dower in the property to William Lawson. Disputes arose between Benjamin Johnston and William Lawson respecting the personal estate of Edward Smith, and the freehold and copyhold property of Robert Smith, deceased, but by an Indenture made the 6th November 1682, between Benjamin Johnston and Ann his wife, Nathaniel Johnston of Pontefract, Doctor of Physic, Cudworth Johnston of the City of York, Doctor of Physic, and Margaret...
